Nominations, which must be in writing and comply with the registered rules of the Branch, may be made at any time from 29/08/2018.

Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Branch's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than 12:00pm Australian Western Standard Time (AWST) on 12/09/2018.**

How to lodge nominations, nominations must be lodged via the following method(s):

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 08 6363 8011 to enquire about the status of your nomination.

Withdrawing Nominations

Nominations cannot be withdrawn after 12:00pm (AWST) on 12/09/2018.

Candidate Statements

Candidate Statements which comply with the rules of the Organisation and shall not exceed 200 words may be submitted to the Returning Officer in support of the candidature (Federal Rule 47.4 and Standard Branch Rule 85.5) along with a black and white passport size photograph of the candidate if so desired. The Statement must be submitted to the Returning Officer as a word document (.doc) by email to waelections@aec.gov.au along with the photograph **by no later than 12:00pm (AWST) 19/09/2018.**

Voting Period

The ballot, if required, will open on 03/10/2018 and close at 10:00am (AWST) on 23/10/2018.

Scrutineers

A candidate in an election may appoint a scrutineer who is a financial member of the Federation to represent him or her in the counting of the ballot (Federal Rule 50.1).

The appointment of scrutineers opens 23/10/2018 and concludes at the end of the counting of the ballot.

A form is available from the Returning Officer for the purpose of appointing Scrutineers.
